## EXHIBITOR INFORMATION

1. Trials will be held indoors in an unheated barn on concrete floors. Indoor blind, 10' x 20'. No indoor crating is available.
2. There is parking adjacent to the barn and additional parking elsewhere on the Exhibition grounds.
3. The Barn Hunt Trials are being held in conjunction with multiple CKC events. Barn Hunt rules apply within Barn 3, the designated parking lot and the immediate area. CKC rules apply beyond those areas.
4. **If you are involved in the CKC events:** An approximate running order will be posted each day. Please check the schedule and advise the Trial Secretary immediately of any potential conflict. Every reasonable effort will be made to accommodate you, but if you have not arrived by the time your Barn Hunt class has ended, you will not be able to run your dog in that class for that trial.
5. There are no cooking facilities at the trial site. Morning tea and coffee will be provided. The site is wheelchair accessible. There is a washroom nearby.
6. **Smoking is not permitted anywhere in the Barn Hunt precincts.**
7. Dogs must be on lead (maximum 6') except in the ring and under control at all times. Note that dogs can become highly excited in this environment. Be proactive in managing your dog(s) and respect the needs of other dogs and handlers.
8. Electronic collars, bark collars, head halters and muzzles may not be used on the trial grounds. Dogs may not be brought to the ring on flexi-leads or prong collars. Dogs will run naked in the ring.
9. Bitches in season may participate, but must be kept separate from other dogs and crated outdoors, must wear panties at all times while on the Barn Hunt trial grounds and will run last in each event for which they are entered. **Advise the trial secretary as early as possible if you will be bringing a bitch in season.**
10. Competitors with multiple dogs will run in different staging groups.

## AWARDS

Ribbons will be awarded for qualifying runs in all A and B classes and for first to fourth place at each height division in all A classes except Instinct. Rosettes will be awarded to all dogs earning titles.

## DOG AGGRESSION

Any dog behaving in a threatening or aggressive manner towards another dog or person may be dismissed from the trials in accordance with trial hearing guidelines and BHA rules.

## SAFETY

The safety of human participants, dogs and rats is of primary concern. By entering these trials, competitors commit to following all instructions and direction from the judge or trial officials.

## REFUNDS

No refunds after the closing date (May 1) except for sick or injured dogs with submission of a note from a veterinarian. Submit refund request no later than the day of trial. Refunds will not be issued for dogs who are absent, disqualified, excused or otherwise barred from participating by the judge or the trial committee.

## VOLUNTEERING

Come prepared to volunteer. Volunteer sign-up information will be provided at the trial.
